**To reserve your wedding date, we must receive *BOTH the contract, properly filled out in full, and a 30% deposit.* If it is incomplete, or incorrect, it will not be accepted.** Please call our office with questions before sending the contract. Once the contract is properly filled out, please scan and email **(DO NOT TAKE A PHOTO)**. Send it to the email address is listed at the top of the contract and call the office with your credit card info for the deposit.

Once the contract and credit card info has been received, the date is yours. Your deposit is non-refundable once the contract is received. The remainder of the payment is due the day of your wedding and does not change even if someone decides against makeup/hair. If more people decide to have makeup/hair, other than what is listed on the contract, another contract will need to be sent in with corrections and additional deposit.

Traveling outside of the Beltway 8 requires a trip charge. If this is the case, please use the trip charge chart available in the PRICING section of the website, with the starting point of 1907 Southwest Freeway, 77098. The bride is also responsible for each parking/valet of Makeup Artist(s) and Hair Stylist(s) separately.

Client agrees and understands that all makeup artists and hair artists are independent contractors. Clients further agree to indemnify and hold harmless [WWW.MAKEUPBYJENTRY.COM](http://WWW.MAKEUPBYJENTRY.COM) affiliates, officers, agents, employees, consultants, contractors or subcontractors from any claims of liability, losses, damages, or any expenses whatsoever as a result of any claims, demands, damages, costs or judgments, including but not limited to, claims based on negligence against it, that may arise in connection with the services performed by an independent contract artist. This agreement is intended to be an addendum to any previous conditions, releases, or hold harmless agreements, in written form, verbal or manually communicated between [WWW.MAKEUPBYJENTRY.COM](http://WWW.MAKEUPBYJENTRY.COM) and its clients in connection to makeup and hair services. Therefore, clients release [WWW.MAKEUPBYJENTRY.COM](http://WWW.MAKEUPBYJENTRY.COM) and its representatives and subsidiaries of all claims of injury, seen or unseen that may occur as a result of any makeup or hair service including but not limited to makeup application and hairstyling. The client will be the responsible party for the total fee of the service package (herself and her party, if individuals listed as payees are unable to tender funds on the day of the event.) All the rates are based on the information stated in this contract (date of the event, number in party, traveling location, time of the event, makeup style). If you must change any information already stated above or spoken, we recommend you consult with Jentry Kelley 72 hours before your wedding day. **Makeup Artist(s) and Hair Artist(s) are subject to change. If for any reason the artists are unable to perform services for your wedding, another artist will be assigned. This includes situations where the makeup or hair artist becomes ill or is no longer employed with the company.**

**Cancellation and Postponement:**

If the wedding is canceled for any reason, the client forfeits the deposit. If your wedding needs to be postponed due to unforeseen circumstances where services cannot be performed due to a government mandate or a natural disaster (i.e. a global pandemic, flooding, or another similar event), we will transfer the deposit the first time to a second date that has been agreed upon by both parties. There will not be any additional fees to reschedule. If the wedding needs to be rescheduled a third and fourth time, or anytime thereafter, the deposit will not be transferred and you will need to pay the deposit again, in full, to rebook. If Jentry Kelley, or anyone on her team, is not available for the postponement or reschedule of your wedding, the client forfeits the deposit.
