Requirements:

- Please NO ALCOHOL DURING THIS EVENT
- The first hour is a formal makeup class. Please have your guests arrive 10-15 minutes before the class beginning.
- All guests must arrive without makeup on.
- We do not go through or organize your bag for this type of event.
- Each person will have their makeup applied, color-matched, and will be given a customized homework sheet with all colors used. Allow 20 minutes per person after the formal makeup class.
- Makeup will be available for purchase.

Pricing:

The minimum for this class is for 6 people. If you want to book makeup lessons for 5 or less, this needs to be done during business hours, and no contract is needed.

Rate: \$50/person (minimum 6 people). **If the contract is for 6 people, and less than 6 attend the class, the rate goes to \$150/person. No exceptions. Anyone who attends the class pays the entry fee.**

A 50% deposit is due to book. Please call the number listed above to provide your credit card information. The remaining 50% is due the night of the event. **CASH ONLY.**

Cancellation:

Once the contract is signed and the deposit is paid, the clients forfeit the deposit and the right to reschedule. If the class needs to be rescheduled, the deposit will be forfeited, and a new deposit will need to be paid to rebook a new day.

All makeup products used are hypoallergenic, However, it is the client's responsibility to advise the artist if she or he is known to have any allergies. The clients agree and understand that all makeup artists are independent contractors. Clients further agree to indemnify and hold harmless **JENTRY KELLEY COSMETICS** affiliates, officers, agents, employees, consultants, contractors or subcontractors from any claims of liability, losses, damages, or any expenses whatsoever as a result of any claims, demands, damages, costs or judgments, including but not limited to, claims based on negligence against it, that may arise in connection with the services performed by an independent contract artist. This agreement is intended to be an addendum to any previous conditions, releases, or hold harmless agreements, in written form, verbal or manually communicated between **JENTRY KELLEY COSMETICS** and its clients in connection to makeup and hair services. Therefore, clients release **JENTRY KELLEY COSMETICS** and its representatives and subsidiaries of all claims of injury, seen or unseen that may occur as a result of any makeup including makeup application. The clients will be the responsible party for the total fee of the service package (herself and her party, if individuals listed as payees are unable to tender funds on the day of the event). All the rates are based on the information stated in this contract. If for any reason you must change any information already stated above or spoken, we recommend you consult with Jentry Kelley 72 hours before your Group Makeup Class. **Makeup Artist(s) are subject to change. If for any reason the artists are unable to perform services for your Group Makeup Class, another artist will be assigned. This includes situations where the makeup artist becomes ill or is no longer employed with the company.**

Cancellation and Postponement:

If the Group Makeup Class is canceled for any reason, the client forfeits the deposit. If your Group Makeup Class needs to be postponed due to unforeseen circumstances where services cannot be performed due to a government mandate or a natural disaster (i.e. a global pandemic, flooding, or another similar event), we will transfer the deposit the first time to a second date that has been agreed upon by both parties. There will not be any additional fees to reschedule. If the Group Makeup Class needs to be rescheduled a third and fourth time, or anytime thereafter, the deposit will not be transferred and you will need to pay the deposit again, in full, to rebook. If Jentry Kelley, or anyone on her team, is not available for the postponement or rescheduled date of your Group Makeup Class, the client forfeits the deposit.
